Uraian Kejadian	<p>Pada tanggal 23 Oktober 2020, Perseroan telah melakukan pembukaan kembali kegiatan operasional bioskop CGV di Kota Mojokerto, yaitu CGV Sunrise Mall.</p> <p>Pembukaan kembali bioskop CGV setelah mendapatkan Sertifikat Layak Operasi yang ditandatangani Walikota Mojokerto selaku Ketua Gugus Tugas Percepatan Penanganan (“GTPP”) Covid-19 Kota Mojokerto beserta Tim GTPP Covid-19 lainnya. Sertifikat Layak Operasi didapat setelah protokol kesehatan dilaksanakan dengan baik sesuai dengan peraturan dan ketentuan percepatan penanganan Covid-19 di Kota Mojokerto. Bioksop CGV akan terus dimonitoring serta dievaluasi secara berkala oleh Tim GTPP Covid-19.</p> <p>CGV telah menyiapkan sejumlah protokol kesehatan sesuai dengan panduan Kementerian Kesehatan dan Pemerintah Kota Mojokerto serta akan menerapkannya dengan ketat, diantaranya:</p>

	<p><i>Detail of Event</i></p>	<ul style="list-style-type: none"> a. Staf dan penonton wajib memakai masker di seluruh area bioskop; b. Mengecek suhu tubuh penonton sebelum masuk ke area bioskop; c. Melakukan sistem pelacakan pengunjung (<i>Tracing</i>) dengan QR Code dan Manual; d. Mengurangi kapasitas tempat duduk di ruang auditorium guna menjaga jarak aman antar penonton; e. Pembersihan didalam auditorium, termasuk tempat duduk, sebelum dan setelah penayangan film; f. Menyediakan gel pembersih tangan/<i>hand-sanitizer</i>; g. Menghimbau penonton untuk memesan tiket menonton serta makan dan minum secara <i>online (contact-less)</i> dengan pembayaran secara digital (<i>cash-free</i>) melalui situs web dan aplikasi digital CGV; h. Penempatan materi komunikasi kepada pengunjung di seluruh area CGV dan secara <i>online</i> untuk meningkatkan pengetahuan tentang protokol kesehatan di bioskop. <p>Perseroan akan selalu berkoordinasi dengan Pemerintah Kota Mojokerto dan mematuhi instruksi pemerintah, termasuk mengikuti aturan pembatasan kapasitas di dalam auditorium maksimal 30% (tiga puluh persen). Meski demikian, Perseroan berharap dengan pembukaan kembali bioskop CGV:</p> <ul style="list-style-type: none"> a. bisa menggairahkan kembali aktivitas rumah produksi (<i>production house</i>) dalam memproduksi film-film nasional; b. membantu memulihkan ekonomi di sektor industri kreatif lainnya; c. membuka kembali peluang lapangan kerja di sekitar bioskop CGV beroperasi; d. masyarakat bisa kembali menonton di bioskop dengan aman dan nyaman dengan menerapkan protokol kesehatan yang ketat. <p><i>On 23 October 2020, the Company has reopened the operational activity of CGV cinema in Mojokerto City, namely CGV Sunrise Mall.</i></p> <p><i>The reopening of CGV cinema after obtaining an Operational Eligibility Certificate signed by Mayor of Mojokerto as Chair of the Covid-19 Handling Acceleration Task Force (“GTPP”) for Mojokerto City along with the other Covid-19 GTPP Team. The Operation Eligibility Certificate is obtained after the health protocol is implemented properly in accordance with the regulations and provisions for accelerating the handling of Covid-19 in Mojokerto City. The CGV cinema will continue to be</i></p>

		<p><i>monitored and evaluated periodically by the GTPP Covid-19 Team.</i></p> <p><i>CGV has prepared several health protocols in accordance with Ministry of Health and Mojokerto City Government guidelines and will strictly implement them, including:</i></p> <ol style="list-style-type: none"> <i>a. Staff and audiences are required to wear masks throughout the cinema area;</i> <i>b. Check the audience's body temperature before entering the cinema area;</i> <i>c. Perform visitor tracking system (Tracing) with QR Code and Manual;</i> <i>d. Reducing the seating capacity in the auditorium space in order to maintain a safe distance between the audiences;</i> <i>e. Cleaning in the auditorium, including seats, before and after the film screening;</i> <i>f. Provide hand-sanitizer;</i> <i>g. Urging audiences to order tickets and food also beverage through online (contact-less) with digital payments (cash-free) through CGV website and CGV digital application;</i> <i>h. Posting of communication material to visitors throughout the CGV area and online to increase knowledge of health protocols in cinema.</i> <p><i>The Company will always coordinate with the Mojokerto City Government and comply with government instructions, including following the rules for limiting capacity in the Auditorium to a maximum of 30% (thirty percent). However, CGV hopes that with the reopening of CGV cinema:</i></p> <ol style="list-style-type: none"> <i>a. expected to revive the activities of production houses in producing national films;</i> <i>b. help restore the economy in the other creative industry sectors;</i> <i>c. reopening job opportunities around the CGV cinema operation; and</i> <i>d. people can return to watching in cinema safely and comfortably by implementing strict health protocols.</i>
